DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Drilled to total depth of 4780'. Ran 9-5/8" OD casing to 4780' and cemented with 3650 sacks. The Halliburton process was used and cement circulated to surface. Cement set 48 hours and on October, 17, 1951, at approximately 12:00 midnight drilled plug and tested casing shut-off. Shut-off tested o.k.
