Drilled to total depth of 4805'. Ran 9-5/8" casing to 4792' and cemented with 3250 sacks cement. Halliburton Process was used and cement circulated to surface. Let cement set 48 hours and on December 3, 1951, at approximately 5:00 p.m., drilled plug and tested casing shut-off. Shut-off tested o.k.
