DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 11 joints 345' of 13-3/8" OD 48# H-40 B-2 SS Casing. Set and cemented at 360' w/425 sacks Regular Neat cement. Plug at 345'. Maximum pressure 275#. Cement circulated.

After waiting over 24 hours tested 13-3/8" casing w/1000# pressure for 30 minutes. There was no drop in pressure. Drilled cement plug from 345' to 360', tested cement below casing shoe w/600# pressure for 30 minutes. There was no drop in pressure.

After approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to drill ahead.
