1. Pull tubing.
2. Perforate 5 1/2" casing 12,430' - 12,442', 12,451' - 12,460' w/2-1/2" JSPF.
3. Run tubing w/retrievable BP and packer. Set BP @ 12,475' & packer above 12,430'. Swab test.
4. If necessary, acidize as warranted. Test.
5. Contingent on above testing, pull retrievable BP, set permanent BP or place perforated interval on production with open hole.
