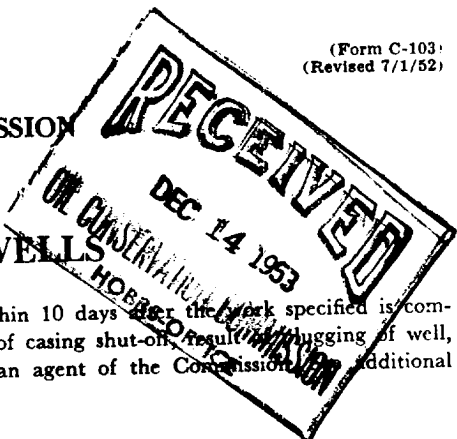

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 11,310' of 7" casing and cemented at 11,323' with 400 sacks 4% gel and 200 sacks neat cement. Did not circulate cement. After WOC 12 1/2 hours ran temperature survey. Top of cement indicated to be at 11,020'. After WOC 70 tested casing with 1500 psi for 30 minutes. Drilled cement to 11,325' and tested cement with 1000 psi for 30 minutes. Test OK.
