Western Company acidized Devonian Formation through casing perforations 12640' to 12670' with 500 gallons mud acid. Flushed with 48 barrels oil. Maximum tubing pressure 5400#, minimum 3500#. Swabbed 6 hours, recovered flush oil and acid water. Flowed to tanks 4 hours, 3/4" choke, 16-1/2 barrels oil. Flowed 8 hours, 1/2" choke, 50 barrels oil, 8/10 of 1% BS. Gravity 45. GOR 1089. Flowing tubing pressure 100#.
