DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Drilled well to 4660'. Ran 131 joints, 4645' of 8-5/8" OD casing set at 4655'. Cemented with 2250 sacks 8% gel and 150 sacks common. Pumped plug to 4636'. Cement circulated to surface. Tested casing with 1000# for 30 minutes before and after drilling plug. No pressure loss.
