There was no drop in pressure. Unseat retainer, displace water w/mud. Ran 110 jts 4653' of 7" OD 8 RT 32# S-95 & 26# S-95, 23# N-80 & 23# J-55 SS casing - liner. Set and cemented at 9249' thru $4\frac{1}{2}$ " DP w/9-5/8" x 7" x 6' Type C Brown Oil Tool casing hanger. Top liner at 4596'. Top casing hanger 4590'. Cemented w/920 sacks 4% Gel Trinity Inferno cement. Displaced cement w/232 bbls mud to 9155'. Picked up DP 15' above top liner hanger at 4575' and back washed approximately 100 sacks cement. Maximum pressure 3800#. Completed 1:10 PM July 14, 1952. Drilled out cement from 4575' to top of 7" liner at 4590'. Pulled out & went in hole w/6" bit, found top cement in 7" liner at 9100'
