Deepen well from 6270' to 6385'. Set 5 1/2" Baker AD-1 Packer at 6017' on 184 joints of 2 3/8" IPC tubing. Pressure tested up on casing to 500# for 30 minutes. Held OK. Treated with 15 tons of CO2 followed by 8000 gallons of 20% NEFE HCL Acid.

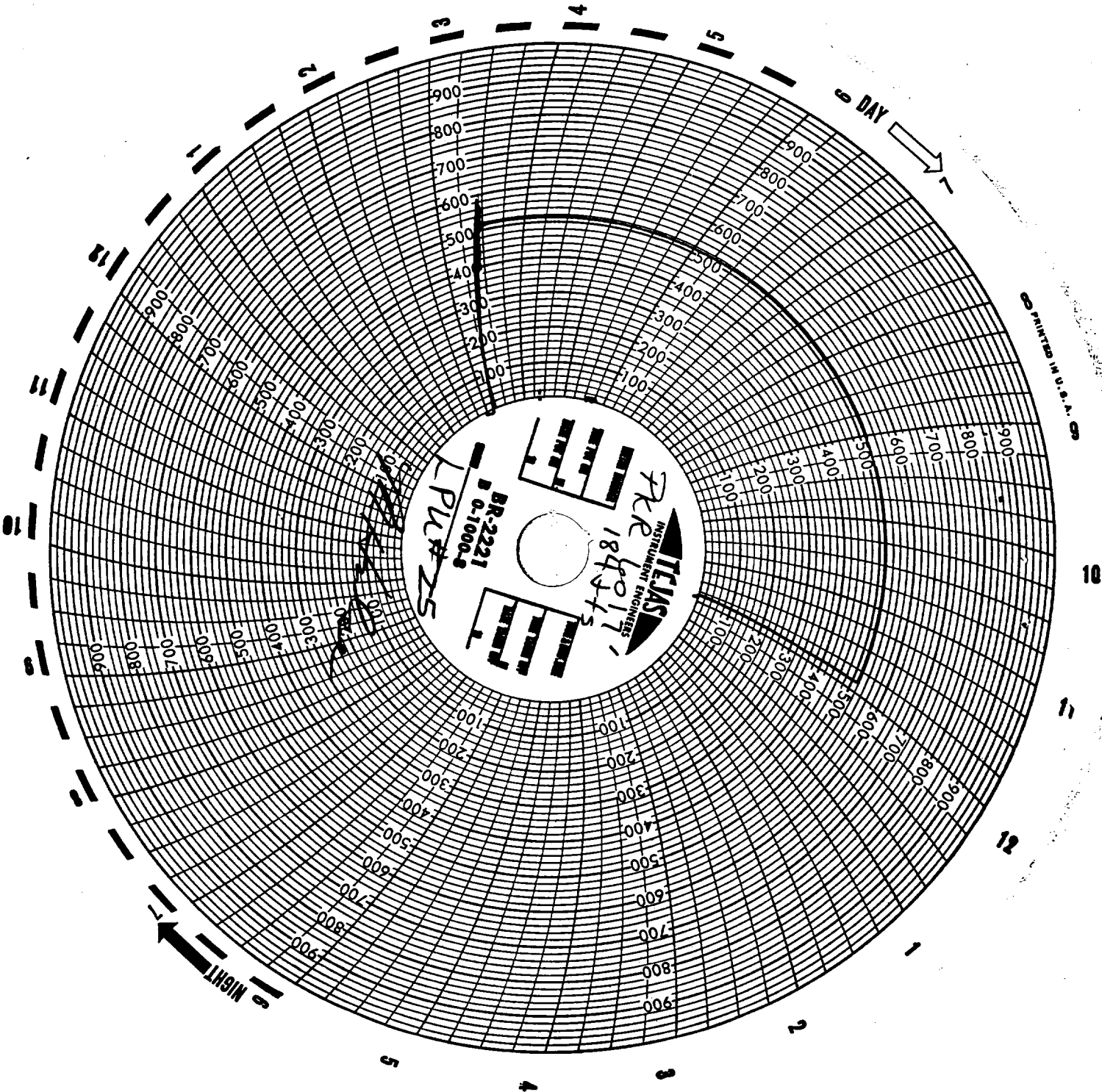
