Fill hole with mud laden fluid. Spot 30 sx plug from 12,605-12,685. Spot 30 sx plug from 4674-4754. Attempt to pull 9-5/8" casing at 3300'. Spot one - 15 sx plug at bottom of surface casing and one - 15 sx plug at surface. Cement a 4" O.D. steel marker in well, with top 4' above mean ground level.
