Ran 125 jts of 9-5/8" 36 & 40# J-55 & H-50 casing and set at 4828' D.P.

Cemented with 2400 sacks with 4% Pozmix & 400 sacks with 2% Pozmix. Plug down at 1 AM 7/19/54 & cement was circulated to surface.

9-5/8" casing was tested with 1000# pressure for 30 minutes with no decrease in pressure. Results OK.
