Detailed account of work done, nature and quantity of materials used, and results obtained.

Moved in Rotary. Drilled out cement in top and bottom of 13-3/8" CD Casing. Drilled to total depth of 1950. Electric logs and magnetic survey indicated that failed to drill into inside of 9-5/8" CD Casing. Shut down, filled hole w/heavy mud, temporary abandoned hole while awaiting sturge and decisions as to possible consideration and use of some other well in area for water disposal rather than this well.

(Note: This well originally drilled by Argo and plugged and abandoned as dry hole with cement plugs across top of 9-5/8" CD Casing stub at 1180 and in bottom of 13-3/8" CD Casing at 316' and bottom of cellar and top of 13-3/8" Casing) (Well re-entered in attempt to convert and use as salt water disposal well disposing of water into San Andres formation approximately 4577-4580 as approved by MOCG Order No. 541-35)

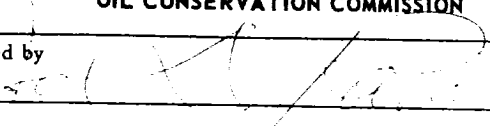
