DETAILS OF WORK

It is our intention to drill a well with rotary tools at the above location to a total depth of approximately 4200'. All casing points will be cemented in accordance with approved methods of the U. S. Geological Survey and any other special requirements will be complied with.

It is planned to use the following casing pattern: 12 1/4" hole to be drilled, 8 5/8" casing to be set at approximately 200' and cemented with 135 sacks, cement to be circulated, 7 7/8" hole to be drilled, 5 1/2" casing to be set at approximately 4200' and cemented with 775 sacks. It is calculated the cement for the 5 1/2" casing will return to 900'.

Approval to produce this well upon completion is also requested.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

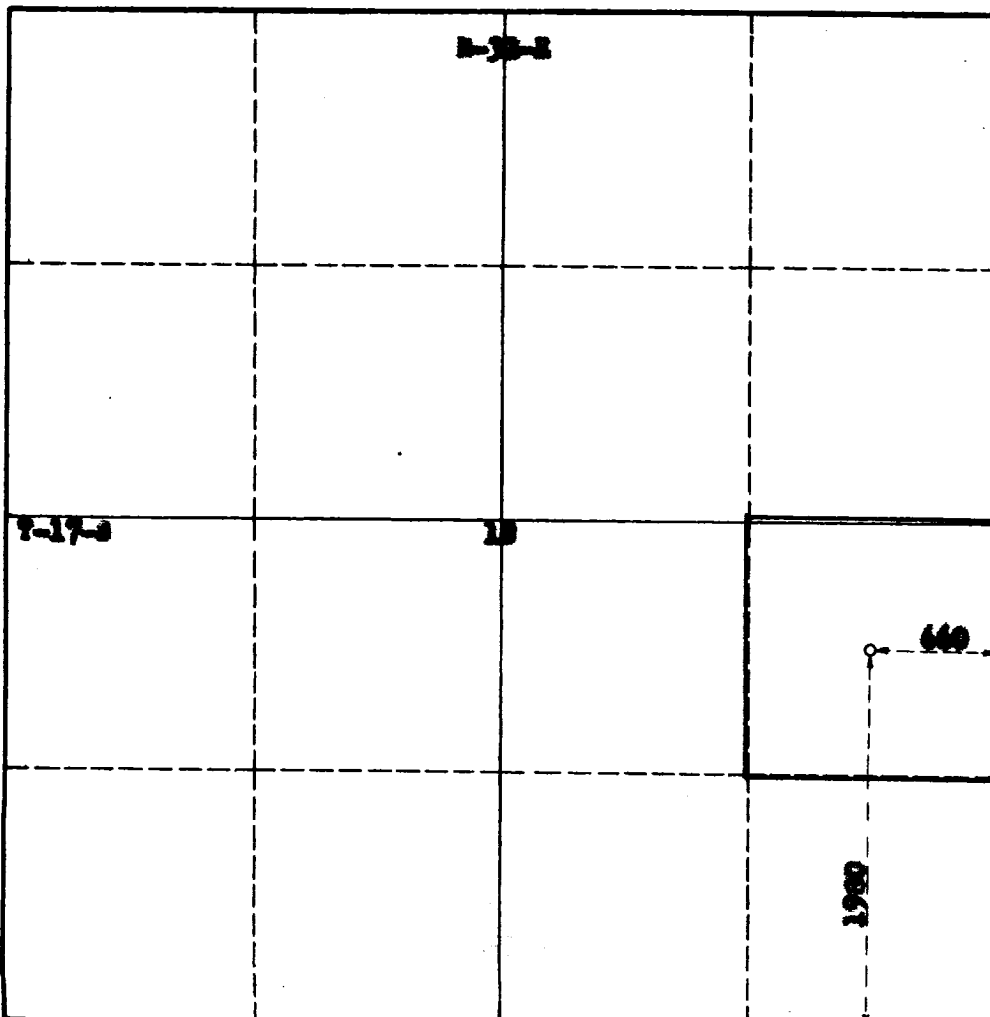
