## DETAILS OF WORK

(State names of and expected depths to objective sands; show sizes, weights, and lengths of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work)

It is our intention to drill a well with rotary tools at the above location to a total depth of approximately 5,350'. All casing points will be cemented in accordance with approved methods of the U.S.G.S. and any other special requirements will be complied with. It is planned to use the following casing pattern: 11" hole to be drilled, 7 5/8" casing to be set at approximately 750' and cemented with 150 sacks, cement to be circulated, 6 7/8" hole to be drilled, 5 1/2" OD casing to be set at approximately 5350' and cemented with 250 sacks. It is calculated that the cement behind the 5 1/2" casing will return to 550'.

Approval to produce this well upon completion is also requested.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

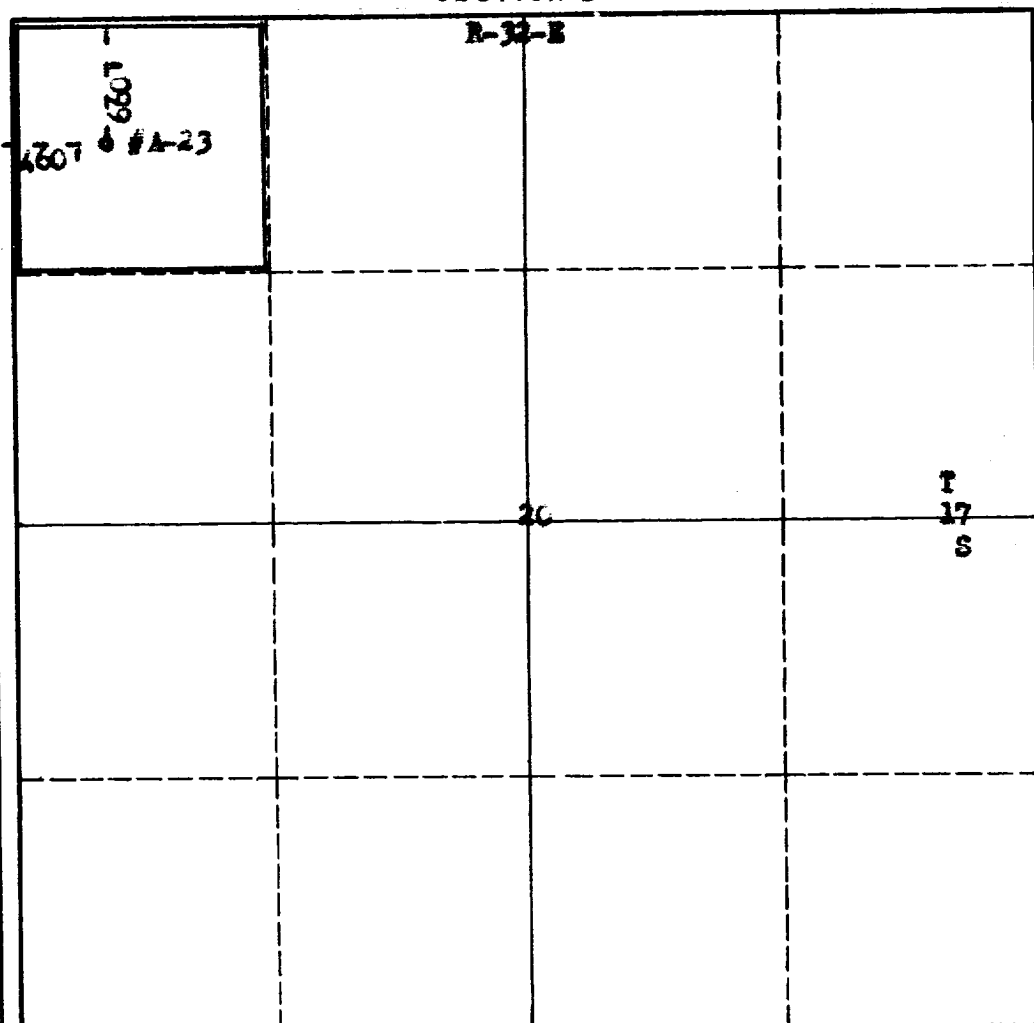

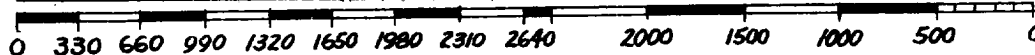
