Completed following work: Set cement plugs as follows; 13,965-855 w/50 sax, 12,250-195 w/25 sax, 11,965-910 w/25 sax, 11,660-605 w/25 sax, 10,465-410 w/25 sax, 9100-9045 w/25 sax, 7555-7500 w/25 sax, 6750-6695 w/25 sax. 7" casing set at 5578' with 138 sax cement. Selectively perforated and tested Paddock formation as follows: 5366-72, 5414-22, 5435-43, 5474-86, 5498-5506. Treated thru perforations 5366-72 with 2,250 gallons acid. Squeezed perforations as follows: 5366-72 w/30 sax, 5414-22 w/30 sax, 5435-43 w/50 sax, 5474-86 w/25 sax, 5498-5506 w/40 sax. No oil or gas encountered in commercial quantities. Well temporarily abandoned but not plugged. Work started 7-9-59, completed 7-25-59.
