9-15-95: Ran tubing, tag plug at 3550', circulate mud, test casing, spot 25 sx on top of plug from 3550'-3175', pull tubing to 900', spot 25 sx from 900-525', pull tubing from 150' to surface, circulate 10 sx to surface, cut off wellhead, put in marker, rig down, move off.
