Approval is requested to renew the temporary abandonment status for this well for the reason stated below. The last approved casing integrity test was performed 5/18/92.

An intent to P&A this well was filed 11/16/94 and approved by your office. Conoco as operator of the MCA Unit has determined that there is no further economic use for this wellbore and desires to plug and abandon it. However, complications with other partners in the MCA Unit have delayed this action. Conoco hopes to have this issue resolved by the end of 1995 and to proceed with plugging.
