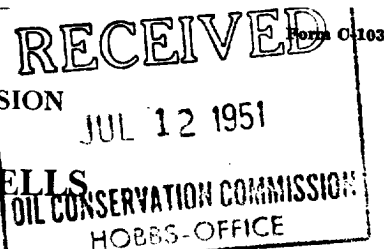

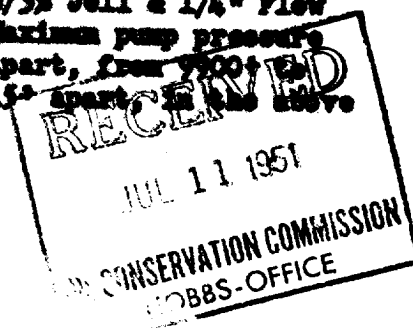

**9915' - Total Depth - Lime & Shale. Ran Schlumberger's Electrical, Gamma Ray & Micro-log Surveys. Ran 5-1/2" O.D., 17# & 15.5#, S.S. New Casing - Set at 9915' & cemented with 600 sacks Trinity Inferno cement, mixed W/3% Jell & 1/4" Flow Seal Per sack. Plug to 9827' at 11:00 A.M., 7-6-51. Maximum pump pressure 1875#. Ran 7 - 5-1/2" Baker Centralizers, spaced 30' apart, from 9800' to 9720', and 14 - 5-1/2" Weatherford Scratchers, spaced 15' apart, in the above section.**
