Ran 4644' of 8-5/8" 32# Seamless H-40 and J-55 casing and set at 4655'. Cemented with 2374 sacks Diamix and 200 sacks of Neat. Circulated 300 sacks. Tested pipe and casing seat with 1000 psi for 30 minutes before and after the drilling out of the cement on February 24, 1955, and both held OK.
