Ran 5½" casing and cemented at 9447 feet with 150 sacks of slo set cement. Did not circulate cement. Stretch test indicated freeze point at 7500 feet. After WOC 15 hours ran temperature survey. Top of cement in annulus at 8680 feet. After WOC 48 hours tested casing with 1500 psi for 30 minutes. Test OK.
