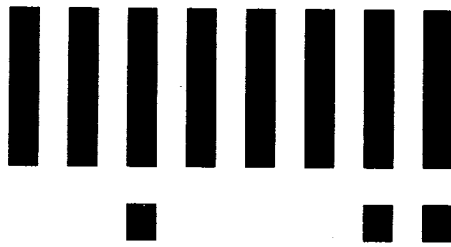

On May 1, 1951, we ran 3637' of 7 1/2" O.D. 200 new casement casing and cemented with 300 sacks by Halliburton. After allowing the cement to set 72 hours, the plug was drilled, hole swabbed and bailed dry and drilling was resumed.
