DETAILS OF WORK

It is our intention to drill a well at the above location to an approximate depth of 4150' to attempt a completion in the Grayburg San Andres horizon. All casing points will be cemented in accordance with approved methods of the USGS, and any special requirements will be complied with.

It is planned to use the following casing pattern: 11" hole, 7 5/8" casing to be set at 950' and cemented with 475 sacks. Cement is to circulate. 6 3/4" hole, 4 1/2" casing to be set at 3900' and cemented with 225 sacks. Cement is to return to 1950'.

Permission is requested to produce the well upon completion.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

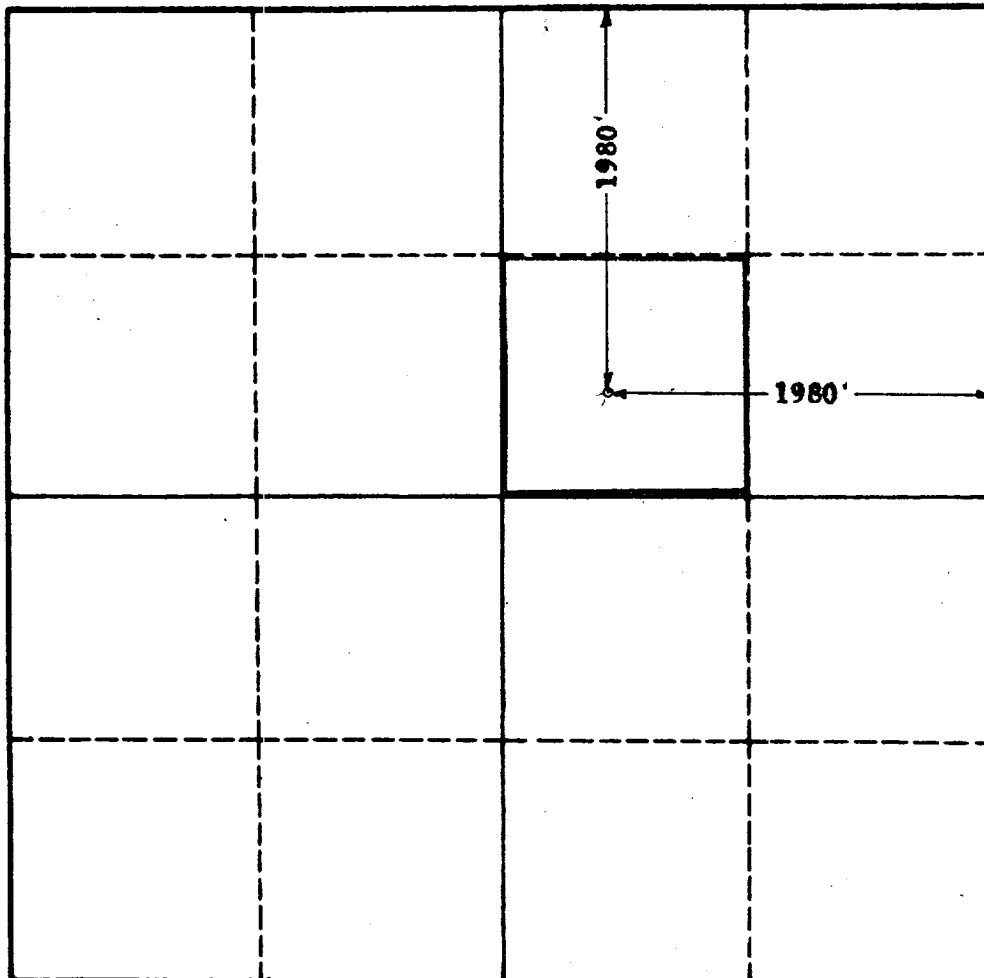

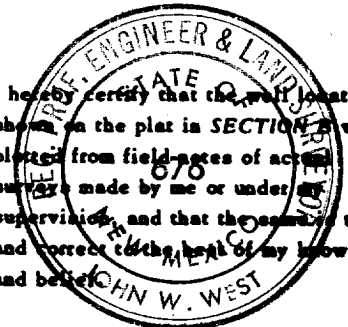
