Gentlemen:

We are in receipt of Commission Form C-103 covering work done on your Southern Union State Well No. 1 located in Unit L of Section 6, T-16-S, R-38-E. This form is lacking in detail, particularly as to the cementing and the setting of the two casing strings which were run in the well. Please file Form C-103 showing the type and weight of casing, type of cement used, waiting on cement time and any pressure tests which were taken on the setting of these two strings of casing.

In addition to the above, the plugging program as outlined on the Form C-103 does not conform with the program given when you obtained verbal permission to plug the well on October 10, 1963. Please recheck your records to determine if the well was plugged in this manner.

To complete this well file it will be necessary that you execute and submit Form C-105, Well Record, and also two copies of a notarized tabulated list of all deviation surveys conducted while drilling the well.

10. The 1982 and 1983-84 seasons were among the driest on record for the United States.
