FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Hole drilled to 8680'. No oil nor gas in commercial quantities was encountered.

We plan to fill the hole with heavy mud-laden fluid through the drill pipe, using a rotary mud pump, and set cement plugs as follows:

50 sacks 8675-8580', 20 sacks 6450-6380', 20 sacks 5010-4970', and 20 sacks 3840-3800'; will pull 8-5/8" OD from approximately 3600' and set plug across shoe of 13-3/8" OD at 322', and cap top with 10 sacks of cement.
