**This well was drilled as a wildcat dry hole and temporarily abandoned May 16, 1963. Temporarily abandoned status was maintained and the 8-5/8" intermediate casing was left intact because this well was considered for future salt water disposal purposes. However, the decision was made to permanently plug and abandon instead.**

**Moved in B&L Casing Pullers, cut 8-5/8" casing @ 1020', pulled & recovered 1008'. Ran 2-1/2" open ended tubing and equalized El Toro regular cement plugs with tubing bottomed as follows: 25 sacks @ 1005', 25 sacks @ 360'. Placed 10 sack plug in top of 13-3/8" casing. Welded 1/2" plate in top of casing and installed dry hole marker. Plugged & Abandoned 4-14-64.**
