**DETAILS OF WORK**

It is our intention to drill a well at the above location to an approximate depth of 4100' to attempt a completion in the Grayburg-San Andres horizon. All casing points will be cemented in accordance with approved methods of the USGS and any special requirements will be complied with. It is planned to use the following casing program: 11" hole, 8 5/8" casing to be set at 900' and cemented w/530 sacks cement. Cement is to circulate. 7 7/8" hole, 5 1/2" casing to be set at 3700' and cemented w/425 sacks cement. Cement is to return to 1800'. This well is to be drilled as a producer and test observation for the proposed MCA Pilot Waterflood. This location is authorized by MCOCC Order No. R-1075 & approved proposed plan of operation submitted with supplement No. 5. Permission is requested to produce this well upon completion.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
