Well spudded 11:00 AM. Drilled 12-1/4" hole to depth of 407'. Pulled out and ran 10 jts 20# 8-5/8" 8 RT casing set same at 405' and cemented in w/175 sx, 100 sx 6% gel, 75 sx regular w/2% HA-5. Cement circulated. 392' casing in well. WOC 18 hrs. Pressured up to 600# on casing for test period of 30 minutes logging no drop in pressure. Drilled ahead making 7-7/8" hole.
