Well drilled and completed 1964 thru perforations 4347'-4091'. Well had become non-commercial and was PA 9-2 77. There were no other producing zones. The plugging procedure was witnessed by U.S.G.S. representative. No. 1 plug of 25 sacks was placed thru tubing from 4150'-3995' in 5 1/2" csg. Top of plug tagged and 5 1/2" csg. was circulated with 100 brine and mud. No. 2 plug thru tubing 25 sacks 2710' 1690'. No. 3 plug perforations (4 holes) made in 5 1/2" csg. at 1305. Then tubing, mixed 75 sacks cement. 50 sacks grouted out thru perforations leaving 25 sacks plugged in 5 1/2" csg. 1305-1095'. No. 4 plug 2 sacks 30'-0' in top of 5 1/2" csg. Steel cap welded on with mallet. No casing pulled.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
