Well was shut in 4-21-78 due to mechanical problems that economically cannot be repaired at current production rate: 1 BOPD and 2 MWPD. Not capable of production in paying quantities. Request temporary abandonment authority while awaiting the evaluation of offset workovers to determine if the same type of workover is applicable to this well. Request temporary abandonment authority until 5-1-79.
