1. Drill 11" hole to 1000 ft. (through red beds) and cement 8-5/8" casing to surface. After WOC 8 hours, nipple up 10" Series 900 double BOP. Pressure test casing with 700 psi for 30 minutes after WOC 12 hours. If test O.K., drill ahead.
2. Drill ahead to total depth of 4500' in 7-7/8" hole.
3. Cement 5 1/2" casing at total depth with 400 ass. cement. Coring and logging will be included in this drilling program.

Verbal approval per Mr. Brown received 5-9-65 to spend.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, as indicated, on all types of lands and leases for appropriate action by either a Federal or a State agency, or both, pursuant to applicable Federal and/or State laws and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 1: If the proposal is to redrill to the same reservoir at a different subsurface location or to a new reservoir, use this form with appropriate notations. Consult applicable State or Federal regulations concerning subsequent work proposals or reports on the well.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

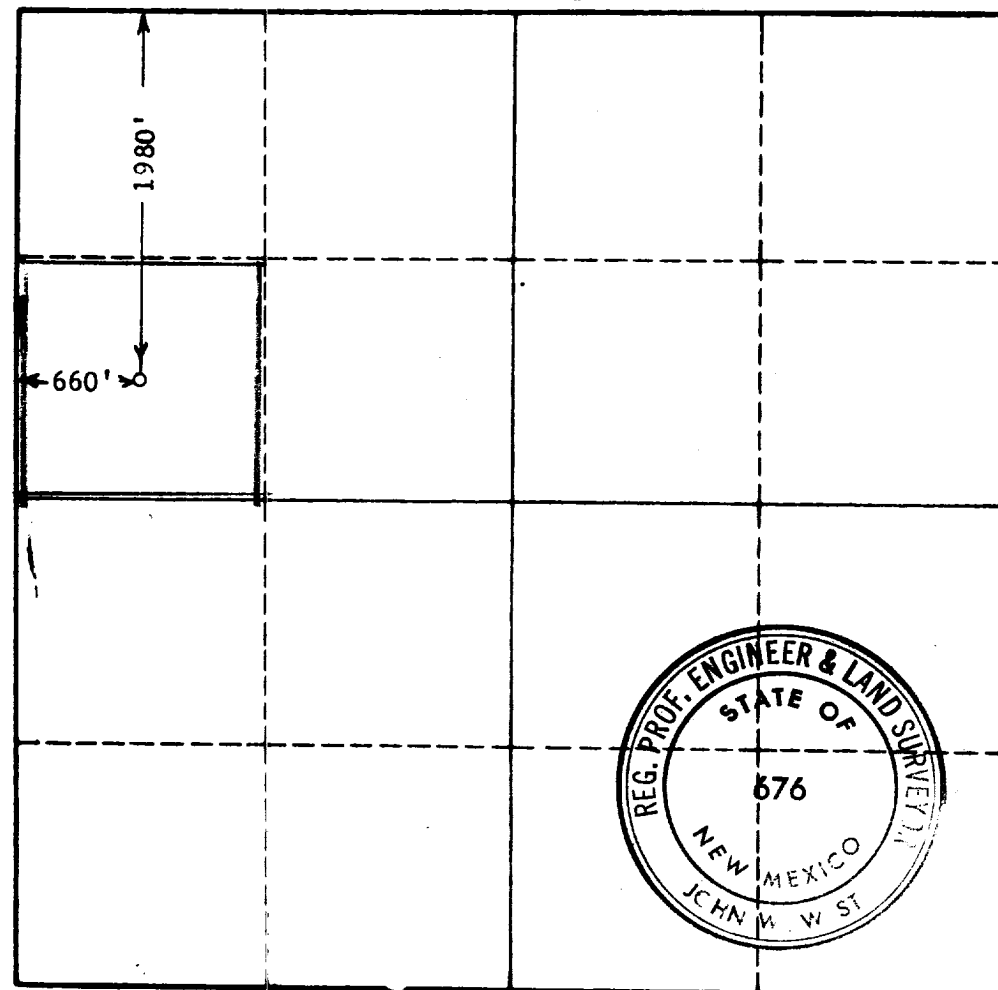
