1. Drill 11" hole to 315', and cement 8-5/8" casing to surface. After WOC 8 hours, nipple up 10" Series 900 double BOP. Pressure test casing with 700 psi for 30 minutes after WOC 12 hours. If test O.K., drill ahead.
2. Drill ahead to total depth of 4500' in 7-7/8" hole.
3. Cement 5 1/2" casing at total depth with 400 sacks cement. Logging will be included in this drilling program.
4. Completion will be set in 5 1/2" casing through pay to total depth. Perforate and treat as required.

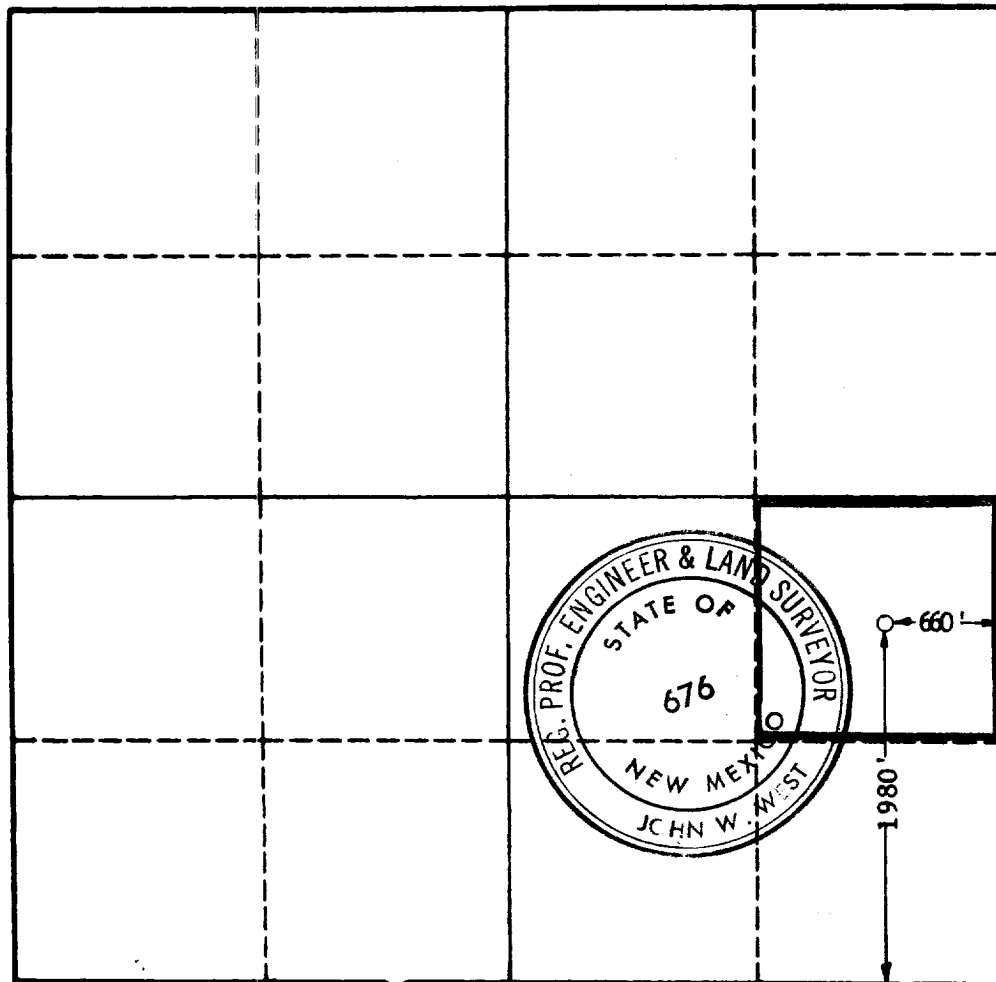
