TD 3330. Ran 8 5/8" casing as follows: 24 joints 32#, H-40 & 80 joints of 24#, J-55; total length 3316' set at 3328'. Cemented w/1800 sax Class C w/4% gel, 10# gilsonite per sack. Cement circulated. Plug down at 4 PM 7-28-68. WOC 24 hours. Tested 8 5/8 casing w/1000 psi for 30 minutes. No drop in pressure. Prepare to drill ahead.
