

4-4-69 After 19 hrs WOC, tested casing w/1,000# for 30 min. - Tested O.K.  
4-9-69 Drilled 11" hole to 4355'. Ran 8 5/8" OD, 24# & 32# csg. to 4355'. - Cemented w/350 sx Class "H" 50/50 posmix 6% gel w/11# salt per sack + 150 sx Class "C" w/5# salt per sack. Plug down @ 8:45 P.M.
