This request for temporary abandonment extension is based on future potential for reactivation of this well. Two different scenarios that could lead to reactivation are still being studied:

1. An infill drilling program in the MCA Unit.
2. Reorientation of the current waterflood patterns.

Interpretation of 3-D seismic surveys being done across the unit is expected to resolve these two possible scenarios.


