Approval is requested to extend temporary abandonment for this well for another year. A valid casing integrity test within the last 5 years should be on file.

This request for temporary abandonment extension is based on future potential for reactivation of this well. Two different scenarios that could lead to reactivation are still being studied:

1. An infill drilling program in the MCA Unit.
2. Reorientation of the current waterflood patterns.

Interpretation of 3-D seismic surveys being done across the unit is expected to resolve these two possible scenarios.
