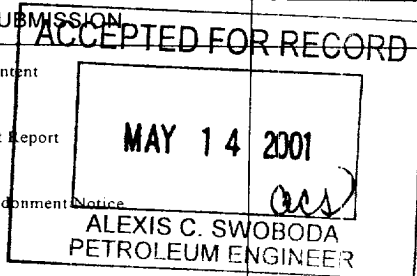

- 4/20/01 MIRU NUBOP and release packer and POOH w/tubing. RIH w/10 stands and SD due to high wind.
- 4/23/01 POOH w/tubing and put on 4 3/4" bit and scraper and RIH. Tagged up @ 3920'. (59" above perfs) Drill out to 4014'. Drill out 95'. SDON
- 4/24/01 Broke circulation and continued to drill out fill. Tagged up @ 4015'. Drilled to 4020', returns had aluminum from old CIBP. Drilled up old plug. Drill out to 4137'. Drilled 122'. Bit plugged off, pulled up 5 stands and SD. Drilled 217' total.
- 4/25/01 POOH w/tubing and bottom joint had sand and paraffin in it. Cleaned out tubing and RBIH, drilled 2' and plugged off again; POOH w/tubing. Tubing had 3' of casing around bit. RIH w/IPC and POOH laying down tubing. RU wire and dumped 5 sx (2 runs) of Class "C" cement. SDON
- 4/26/01 Picked up 1- 2 7/8" x 30 SOPMA SN and 126 jts of 2 7/8" tubing and RIH. Tagged up @ 4132'. Land SN @ 3941', bottom of mud anchor is @ 3996'. NDBOP and flange up wellhead. RIH w/2.5 x 1.5 x 16' RHBC pump, 2 K-bars and 155- 3/4" c rods. Landed pump.
