7-20-98: Move in and rig up, POOH & laid down 2 7/8" tubing, picked up & ran in hole w/10' 2 3/8" PUP jt., 4 1/2" string mill, 2-3 1/8" drill collars on 2 3/8" tubing, stacked out 1939', dropped down to 1954', POOH - attempt to find bad spot. SION.

7-21-98: Picked up and RIH w/ 2 3/8" mule shoe, string mill, drill collars on 2 3/8" tubing; parted casing @ 1939', unable to work wash pipe into casing, POOH. SION.

7-22-98: Ran in hole with 2-3 1/8" drill collars & 2 3/8" tubing, POOH & laid down 2 3/8" tubing & drill collars, removed BOP & installed wellhead, rigged down & moved off.
Left one joint of 2 7/8" J-55 tubing in hole, will evaluate.
