3-23-98: Move in, rig up, tried to unseat pump, rods parted, POOH w/parted rods & laid down, rigged up swab & swabbed tubing down, well started to kick, SION.
3-24-98: Bled well down, removed wellhead & installed BOP, POOH w/tubing & rods, latched on to rods, unable to unseat pump, backed off rods & POOH & laid down, continued POOH w/tubing, picked up 5 1/2" pkr & started RIH, SION.
3-25-98: Continued RIH w/pkr, stacked out on a tight spot @ 3568', unable to work through, pulled up hole & set pkr @ 3553', removed BOP & installed wellhead, rigged down & moved off. Shut off CO2 production.
