Proposal for casing integrity testing procedure:

- I. Set profile plug. Presuure test tub and casing.
- 2. Get off on/off tool, place frac sand on top of packer.
- 3. POOH w/injection tbg, run 30 minute MIT @ 500# in order to get base line.
- 4. Run csg. inspection log from pkr to surface.
- 5. Upon findings, spot cmt, CI C w/low fluid loss, 3/10% CD-32, I.I% FL-62, 2/105 SMS, 5% KCL from 50' below bad casing to 100' above bad casing depths.
- 6. POOH w/tubing.
- 7. Pressure csg. to 600# & monitor. Continue monioring & applying pressure while cement thickens.
- 8. Drill out cement. Pressure test and compare to previous 30 minute MIT test @ 500#, if chart holds will RIH w/on-off tool & injection tbg, circulate sand off on-off tool, latch onto pkr, pull plug, run MIT and return well to injection. If test failure: will repeat cementing procedure using CI C neat cement w/2% NaCl.
