

6-26-98: MIRU, removed well head and installed BOP, dropped down & latched RBP @ 3800', left well open to flowline - shut down.

6-29-98: Unset RBP & POOH, picked up & RIH w/ 2 7/8" gas anchor, seating nipple - SN @ 3777', gas anchor @ 3809', removed BOP & installed wellhead. Ran pump & rods, spaced out pump and hung on. Put well on production.

6-30-98: Rigged down and moved off.
