On 1-6-1975 the above well was plugged & abandoned as follows:

Plug #1 - 35 sacks class "H" cement @ 13,096' to 12,996'
Plug #2 - 35 sacks class "H" cement @ 11,150' to 11,050'
Plug #3 - 35 sacks class "H" cement @ 9,850' to 9,250'
Plug #4 - 35 sacks class "H" cement @ 7,200' to 8,100'
Plug #5 - 35 sacks class "H" cement @ 6,420' to 6,320'
Plug #6 - 40 sacks class "H" cement @ 4,900' to 4,800'

The hole was circulated for 3 hrs. w/8.9# per gal. mud prior to pumping down plugs.

On 1-19-75 pulled 900' 8 5/8" casing from well & finished plugging as follows:

Plug #7 - 50 sacks class "H" cement @ 900' to 800'
Plug #8 - 100 sacks class "H" cement @ 338' to 288'
Plug #9 - 10 sacks class "H" cement @ Surphase

Removed well head & installed dry hole marker. All pits have been filled, location leveled & cleared of junk.
