10-8-91 Ran cast iron bridge plugs, set same 12860 feet. Perforated 11,500 - 11,508 ft. total of 16:43 holes, 11,512 - 11,520 ft 8 ft. 16:43 holes, all total of 32 holes. Set packer 11,536 ft, treated with 1500 gal NEFE acid, swab well down with no commercial oil or gas recovery. Set cast iron bridge plug 11,400 ft. perforated at 10,730 - 10,736, 10,763 - 10,772 total of 30:43 holes. Treated with 4000 gal NEFE acid, swab well back. Swabbing at rate of 15.22 bbl oil per day, no water. Put well back on pump and resumed production.
