Commenced drilling @ 3:00 P.M. 8-31-78 with a spudder. Set 20" conductor pipe at 40' 10-2-78, with Ready Mix to the surface of the ground.

Moved in big Rotary rig and resumed drilling at 7:30 P.M. 10-2-78. Drilled 17-1/2" hole to 376'. Ran 9 joints 13-3/8" 61# casing and set at 376' with 400 sacks Class C cement with 2% calcium chloride. Pumped plug down @ 6:30 A.M. 10-3-78.

Released pressure on casing at 2:30 P.M. on 10-3-78. Nippled up. Waited on cement 19 hrs. Pressure up to 1000# held for 30 minutes with no pressure drop.
