From 8-1-81 through 8-31-81: 4 1/2" casing parted at 8235'. Initiated remedial work to wash over & drill out cement from 4395 - 6000' and recover 4 1/2" casing down to 8235'.

Commenced washing and milling on casing with wash over pipe and tapered mill. Milled to 4395' on 8-5-81. Continued milling with concave mill and washing over with Diamond wash-over shoe. Milled to 4416' with flat btm. mill, on 8-15-81. Washed over 4 1/2" csg to base of 8 5/8" intermediate casing on 8-26-81. Washed over csg to 4570' on 8-30-81.
