- Operator perforated Morrow detrital zone 13,114-13,124' with tubing gun w/4 JSPF and completed natural on 2-14-83.
- Production has declined to almost zero from this zone.
- Operator proposes to perforate the Morrow sand 12,939-41' and 12,973-12,982 with casing gun and treat as necessary to produce.
- Operator plans to re-perforate the Morrow detrital zone 13,114-13,124 with casing gun and treat those perms at the same time the new perms are treated since the old perms were with a tubing gun and were never stimulated. Both Morrow zones will be produced together.
