1-9-87 Ran 106 jts 8-5/8" 32# casing; set at 4585'. Cemented with 1600 sx. Halliburton Lite + 3#/sx salt + 1/4#/sx paper. Followed by 250 sx Class "C" cement. Displaced with 277 barrels fresh water. Bumped plug at 8 PM with 1700#; floats failed. Circulated 300 sx to surface. WOC. Nippled up and tested BOP. Drilled out at 2 PM 1-10-87.
