We propose to drill and test the Queen formation and intermediate zones. Approximately 1550' of surface casing will be set with cement circulated to surface to shut off gravel and cavings. If productive, 5-1/2" casing will be run and cemented with adequate cover, perforated and stimulated as needed for production.

MUD PROGRAM: Native mud to 1550', brine water to TD

BOP PROGRAM: BOP's will be installed at the offset and tested daily

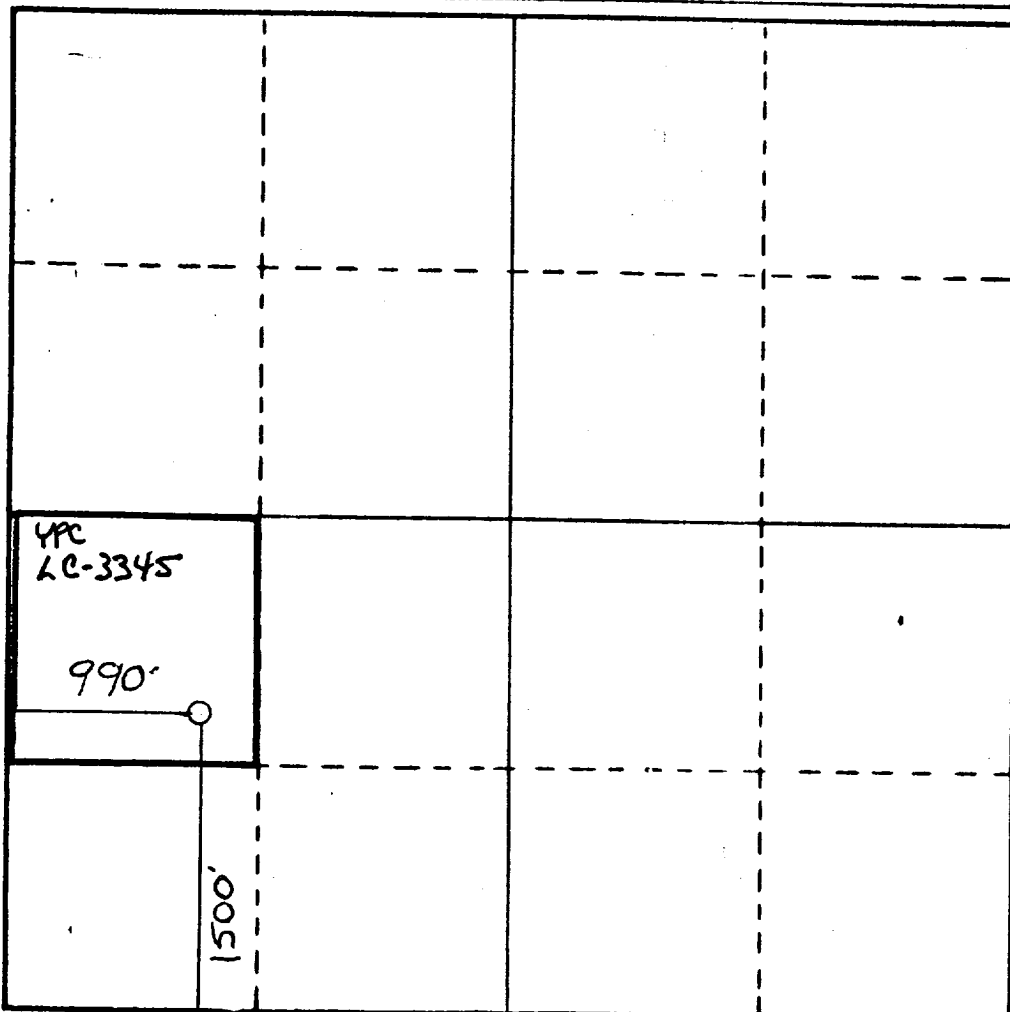

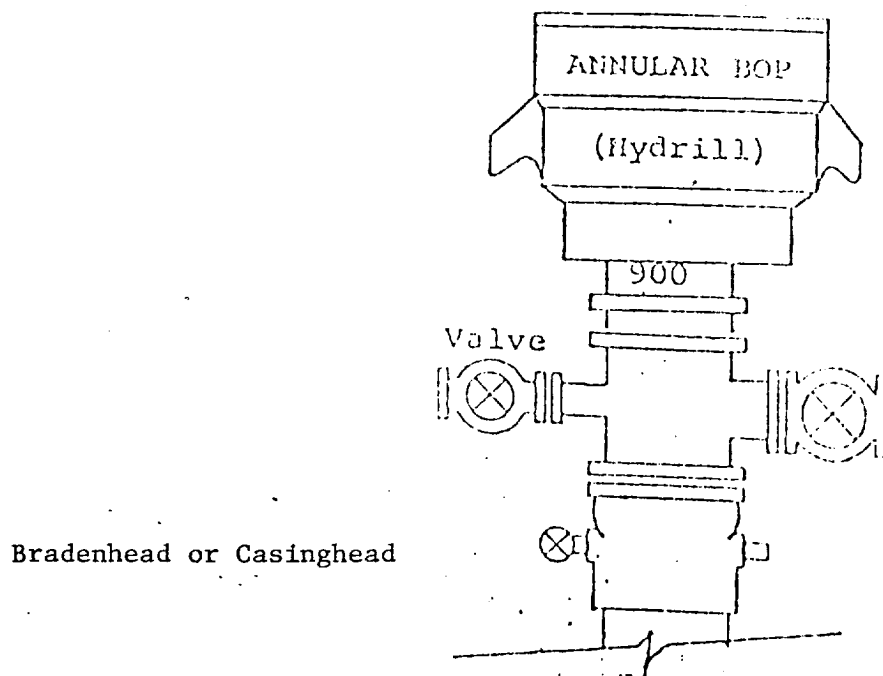
