7-23-99 - Moved in and rigged up pulling unit. Picked up on rods and TOOH. Parted 62 triples with 3/4 body break. TIH with fishing tool and latched onto fish. Unseat pump. TOOH. Released tubing anchor. Nipped up BOP. TOOH with tubing. TIH with bit, scraper, drill collars and tubing to 9335'. Worked scraper up and down thru perfs. 8921-8930'. TOOH. Shut well in.
7-24-99 - TIH with packer with 2.25" seating nipple set at 8853'. Loaded annulus with 2% KCL. Pressured to 500#. Acidized perforations 8921-8930' (Abo) with 5000 gallons 20% Ferchek system with Protex-all for scale. Flushed with 2500 gallons 2% KCL with Protek-all scale inhibitor. Swabbing.
7-25-26-99 - Released packer and TOOH. TIH with production string. Released well to production department.


