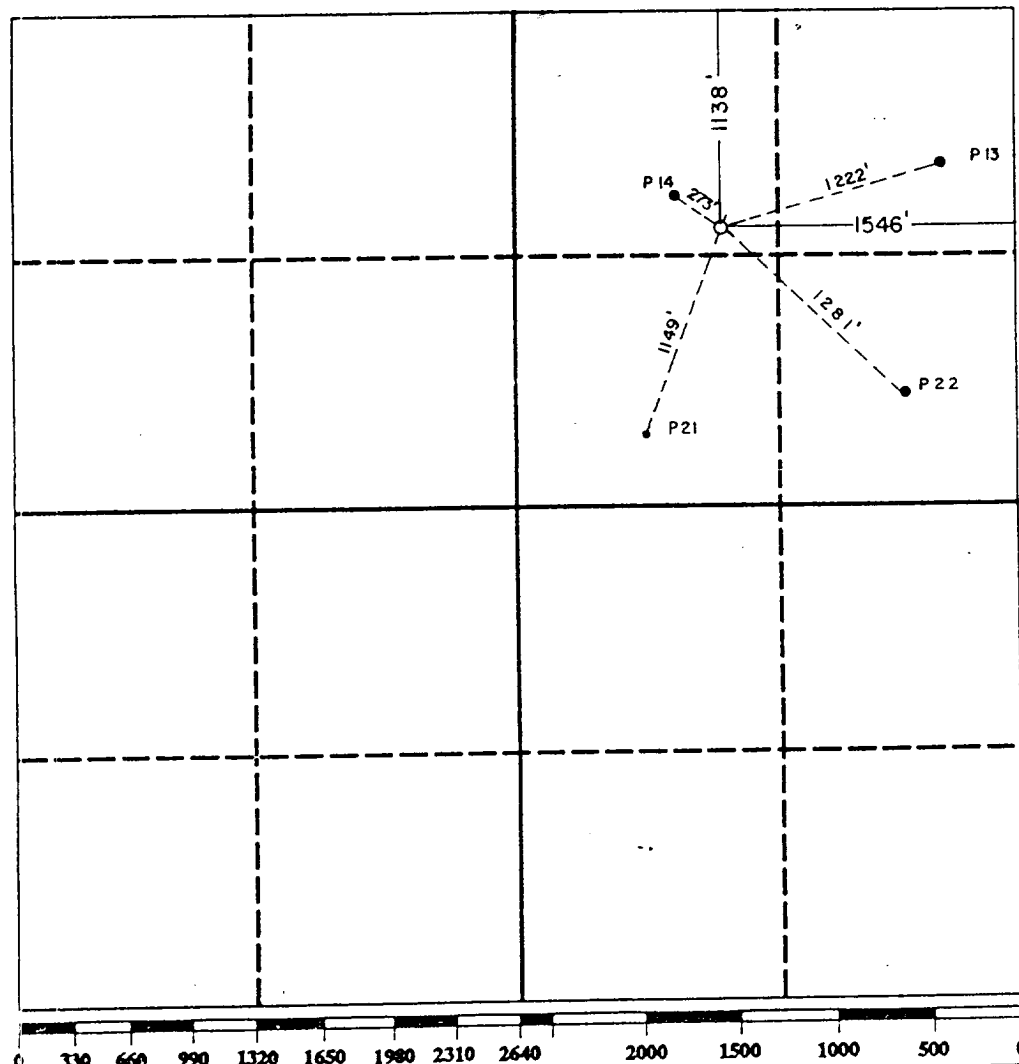

Remarks:

Surface Casing: Run a centralizer on joints 1, 2, 6, and top joint. Run GS, 1 jt, FC and csg. Threadlock bottom 2 joints.

Intermediate Casing: Bottom 600' to be 32# K ST&C w/ a FS, 1 jt, FC & 10 centralizers.

Production Casing: Remove varnish from bottom 900' (sandblast). Run FS, 1 jt, FC. Threadlock the bottom 2 joints. Centralize 1 per jt to top of SA, and 1 every other jt to the top of the Yates. Displace with water after dropping plug.
