Propose to POOH with pump and rods. Load hole w/2% KCL and perforate Wolfcamp as follows:  
9849, 50, 51 and 9859-70' w/15 holes (1 SPF). TIH w/tubing and packer. Move RBP to 10200'  
and test. Acidize perfs 9849-9870' w/1500 gals 15% NEFE acid. Swab test and evaluate.
